BY-LAWS

1 May 1978

These By-Laws are subject to the Articles of Incorporation and Constitution of the Association.

1. Annual Dues - Annual dues for membership in the Association shall be \$5.00 (Five Dollars) per person or \$7.50 (Seven Dollars and Fifty Cents) per family. The fiscal year shall begin on January 1st of each year, and any member shall be in default and his name automatically removed from the rolls of the Association whose dues for the year shall not have been paid by April 30th.

2. Annual Meeting and Regular Meetings - The annual meeting of the Association at which the election of officers shall be held will take place on the second Wednesday of each May. Regular quarterly meetings of the Association will take place on the second Wednesday in September, November, February and May as prescribed by the Articles of Incorporation.

3. Order of Business - At every regular and special meeting of the Association, the order of business, unless otherwise provided for by a three-fourths vote of the members present, shall be as follows:

a. The President or acting Chairman shall call the meeting to order.

b. The minutes of the last preceding regular or special meeting shall be considered.

c. Report of the Treasurer shall be read.

d. The minutes or report of action of the Executive Committee shall be considered.

e. Reports of standing committees, and consideration thereof. Reports of special committees, and consideration thereof.

f. Any matter of business remaining unfinished upon adjournment of the preceding meeting may be raised by motion, and if so raised, shall be considered.

g. Any matter of new business within the powers of the Association shall be considered.

h. The Chairman may present any speaker or guest authorized by the Association.

i. In the event that there is pending, as provided in the Constitution or By-Laws, a proposal for the amendment of the Constitution or By-Laws, submitted as provided in the provisions for the amendment thereof, it shall constitute a special order of business following the consideration of minutes of prior meetings and shall so remain until consideration thereof has been concluded.

j. Upon proper motion, to be carried, the Association shall adjourn.

4. Election of Delegates - Election of delegates when authorized to any other continuing organization, shall be conducted in the same manner as the election of officers of the Association.

5. Sturgis Standard Code of Parliamentary Procedure shall be the standard parliamentary reference.

6. Amendments - The By-Laws may be amended as provided in the Constitution.
